DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR  
ADAMSVILLE PARK

THIS DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS is made this day of  
\_FEBRUARY 14\_, 200\_7\_, by THE DEN-RIC CORPORATION, a Georgia corporation (hereinafter  
referred to as "Declarant").

Declarant is the owner of the real property described in Exhibit "A" attached hereto and  
incorporated herein by reference. Declarant intends by this Declaration to impose upon the Property  
(as defined herein) mutually beneficial restrictions under general plan of improvement for the benefit  
of all owners of real property within the Property. Declarant desires to provide a flexible and  
reasonable procedure for the overall development of the Property, and to establish a method for the  
administration, maintenance, preservation, use and enjoyment of such Property as are now or  
hereafter subjected to this Declaration.

Declarant hereby declares that all of the property described in Exhibit "A" and any additional  
property which is hereafter subjected to this Declaration by Supplemental Declaration (as defined  
herein) shall be held, sold, used and conveyed subject to the following easements, restrictions,  
covenants, and conditions, which are for the purpose of protecting the value and desirability of and  
which shall run with the real property subjected to this Declaration. This Declaration shall be binding  
on all parties having any right, title, or interest in the Property or any part thereof, their heirs,  
successors, successors-in-title, and assigns, and shall inure to the benefit of each owner thereof.

1. NAME.

The name of the property is Adamsville Park (herein after referred to as Adamsville), which is  
a residential property owners' development.

THIS DECLARATION DOES NOT AND IS NOT INTENDED TO CREATE A CONDOMINIUM REGIME  
SUBJECT TO THE GEORGIA CONDOMINIUM ACT, O.C.G.A. 44-3-17, ET SEQ

THIS DECLARATION DOES NOT AND IS NOT INTENDED TO SUBMIT THE PROPERTY TO THE TERMS  
OF THE GEORGIA PROPERTY OWNERS' ASSOCIATION ACT, O.C.G.A. 44-3-220, ET SEQ.

2. DEFINITIONS.

Generally, terms in this Declaration shall have their normal, generally accepted meanings.  
Unless the context otherwise requires, certain terms used in this Declaration shall be defined as  
below.

- (a) Architectural Control Committee or ACC means the committee established to exercise the  
architectural review powers set forth in Paragraph 10 hereof.
- (b) Articles or Articles of Incorporation mean the Articles of Incorporation of Adamsville Park  
Homeowners Association, filed with the Secretary of State of the State of Georgia.
- (c) Association means Adamsville Homeowners Association, Inc., a Georgia nonprofit  
corporation, its successors or assigns.
- (d) Association Legal Instruments mean this Declaration and all exhibits hereto, including the  
Association's Bylaws, and the plats, all as may be supplemented or amended.
- (e) Board or Board of Directors means the elected body responsible to management and  
operation of the Association.
- (f) Builder shall mean a Person which purchases one or more Lots for the purpose of  
constructing improvements thereon for later sale to consumers, or to purchase parcels of  
land within the Properties for further subdivision, development and/or resale in the  
ordinary courts of such Person's business.

- (g) Bylaws mean the Bylaws of Adamsville Homeowner's Association, Inc., attached to this Declaration as Exhibit "C" and incorporated herein by this reference.
- (h) Class "B" Control Period shall refer to the period of time during which the Class "B" Member is entitled to appoint the members of the Board of Directors, as provided in Article III, Section 2 of the Bylaws.
- (i) Common Expenses mean the expenses anticipated or actually incurred by the Association in maintaining, preparing, replacing, and operating the Common Property and otherwise for the benefit of all Lots.
- (j) Common Property shall mean all real and personal property which the Association now or hereafter owns, leases or otherwise holds possessory or use rights in for the common use and enjoyment of the Owners of Adamsville, including easements held by the Declarant for such purpose.
- (k) Community-Wide Standard means the standard of conduct, maintenance, or other activity generally prevailing in the Property. Such standard may be more specifically determined by the declarant, the Board or the ACC.
- (l) Declarant means THE DEN-RIC CORPORATION, a Georgia corporation, and such of its successors-in-title who shall: (i) acquire, from a predecessor "Declarant," and for the purpose of development or sale, all or any portion of the real property described in Exhibit "A" or in Exhibit "B" hereof, and (ii) be designated as the "Declarant" in the deed of transfer by which such successor-in-title shall so acquire its interest in such real property, or by written assignment of Declarant rights in an instrument recorded in the county land records.
- (m) Effective Date means the date that this Declaration is recorded in the Monroe County, Georgia land records.
- (n) Electronic Record means information created, transmitted received, or stored by electronic means and retrievable in human perceivable form.
- (o) Electronic Signature means a signature created, transmitted received, or stored by electronic means and included but is not limited to a secure electronic signature.
- (p) Eligible Mortgage Holder means a holder of a first mortgage secured by a Lot who has requested in writing notice of certain items as set forth herein.
- (q) Lot means a portion of the Property intended for ownership and use as a single-family dwelling site as permitted in this Declaration and as shown on the plats for the Property, or amendments or supplements thereto, recorded in the Monroe County, Georgia land records.
- (r) Mortgage means any mortgage, deed to secure debt, deed of trust, or other transfer or conveyance for the purpose of securing the performance of an obligation, including, but not limited to, a transfer or conveyance of fee title for such purpose.
- (s) Mortgage or Mortgage Holder means the holder of a Mortgage.
- (t) Occupant means any Person occupying all or any portion of a dwelling on a Lot as his or her principle or primary residence for any period of time, regardless of whether such Person is a tenant or the Owner of such property.
- (u) Owner means the record or title holder of a Lot, but shall not include a Mortgage Holder.
- (v) Person means an individual, corporation, firm, association, partnership, trust, or other legal entity.
- (w) Property means that real estate which is submitted to the provisions of this Declaration, as described in Exhibit "A" attached hereto and incorporated herein by reference. This property is a residential property owners' development.
- (x) Secure Electronic Signature means an electronic or digital method executed or adopted by a party with the intent to be bound by or to authenticate a record, which is unique to the person using it, is capable of verification, in under the sole control of the person using it, and is linked to data in such a manner that if the data are changed, the electronic signature is invalidated.
- (y) Supplemental Declaration shall mean an amendment or supplement to this Declaration filed pursuant to Paragraph 18 which subjects additional to property to this Declaration and/or imposes, expressly or by reference, additional restrictions and obligations on the land described therein.

3. LOCATION, PROPERTY DESCRIPTION, AND PLATS.

The Property subject to this Declaration is located in Land Lots 178, 207 and 208 of the 6th District of Monroe County, Georgia, being more particularly described in Exhibit "A" attached to this Declaration, which exhibit is specifically incorporated herein by this reference. A plat relating to the Property has been filed on a plat located at in Plat Book 29, Pages 13 and \_\_\_\_\_ of the Monroe County, Georgia records. The plat of survey is incorporated herein by reference as fully as if the same were set forth in their entirety herein.

#### 4. ASSOCIATION MEMBERSHIP AND VOTING RIGHTS.

- (a) Membership. Every Owner shall be deemed to have a membership in the Association. This is not intended to include Persons who hold an interest merely as security for the performance of an obligation, and the giving of a security interest shall not terminate the Owner's membership. No Owner, whether one or more Persons, shall have more than one (1) membership per Lot owned. In the event of multiple Owners of a Lot, votes and rights of use and enjoyment shall be as provided in this Declaration and in the Bylaws. Membership shall be appurtenant to and may not be separated from ownership of any Lot. The rights and privileges of membership, including the right to vote and to hold office, may be exercised by a member or the member's spouse, but in no event shall more than one (1) vote be cast nor office held for each Lot owned.
- (b) Voting. The Association shall have two classes of membership, Class "A" and Class "B."

(i) Class "A". Class "A" Members shall be all Owners except Class "B" Member. If any Class "A" Members shall be entitled to one equal vote for each Lot in which they hold the interest required for membership under Paragraph 4 (a) hereof; there shall be only one vote per Lot. In any situation where a Member is entitled personally to exercise the vote for his Lot and there is more than one Owner of a particular Lot, the vote for such a Lot shall be exercised as such co-Owners determine among themselves and advise the Secretary of the Association in writing prior to any meeting. In the absence of such advice, the Lot vote shall be suspended if more than one Person seeks to exercise it.

(ii) Class "B". The sole Class "B" Member shall be the Declarant. The rights of the Class "B" Member, including the right to approve, or withhold approval of, actions proposed under this Declaration and the Bylaws, are specified elsewhere in the Declaration and the Bylaws. The Class "B" Member shall be entitled to appoint and remove all directors and officers of the Association during the Class "B" Control Period, as specified in Article III, Section 2 of the Bylaws. After termination of the Class "B" Control Period, the Class "B" Member shall have a right to disapprove actions of the Board of Directors and committees as provided in Article III, Section 3, of the Bylaws.

For purposes of the subparagraph, non-use shall constitute a benefit to less than all Lots or a significant disproportionate benefit among all Lots only when such non-use results in an identifiable, calculable reduction in the cost to the Association.

#### 6. COMMON PROPERTY.

In the event additional phases are added to the terms of this declaration through a Supplemental Declaration, said Supplemental Declaration shall specify whether Common Property is included in that phase, and amend this Paragraph accordingly.

#### 7. ASSOCIATION'S RIGHTS AND RESTRICTIONS

The Association shall have the right and authority, in addition to and not in limitation of all other rights it may have:

- (a) to make and to enforce reasonable rules and regulations governing the use of the Property, including the Lots;
- (b) to enforce use restrictions, other Declaration and Bylaws provisions, and rules and regulations by imposing reasonable monetary fines, exercising self-help powers, and suspending use

and voting privileges and services paid for as a Common Expense, as provided herein. These powers, however, shall not limit any other legal means of enforcing the use restrictions or Association rules and regulations by either the Associate or, in an appropriate case, by an aggrieved Owner.

(c) to grant permits, licenses, utility easements, and other easements, permits or licenses across property owned by it, as necessary for the proper maintenance or operation of the Property as may be reasonably necessary to or desirable for the ongoing development and operation of the Property;

(d) to control, manage, operate, maintain, replace and, in the Association's discretion, alter or improve all portions of the Property for which the Association is assigned maintenance responsibility under this Declaration;

(e) to enter Lots for maintenance, emergency, security, or safety purposes, or otherwise to discharge or exercise its powers or responsibilities hereunder, which right may be exercised by the Association, its officers, agents, employees, managers, and all police officers, firemen, ambulance personnel, and similar emergency personnel in the performance of their respective duties. Except in an emergency situation, entry shall be only during reasonable hours and after reasonable notice to the Owner or Occupant of the Lot. For purposes hereof, any water or other utility leak, fire, strong or foul odor, obvious insect infestation or sounds indicating that a person or animal might be injured or sick and require immediate medical attention shall be considered emergencies justifying immediate entry into a dwelling. No Person exercising the rights granted in this sub paragraph shall be liable for trespass, damages, or in any other manner by virtue of exercising such rights, and failure to exercise any such rights or to exercising such rights in a timely manner shall not create liability to any such Person, it being agreed that no such duty exists; and

(f) to acquire, lease, hold, and dispose of tangible and intangible personal property and real property.

#### 8. ASSESSMENTS.

(a) Purpose of Assessment. The Association shall have the power to levy assessments as provided herein. The assessments for Common Expenses provided for herein shall be used for the general purposes of promoting the recreation, health, safety, welfare, common benefit, and enjoyment of the Owners and Occupants of Lots, as may be authorized by the Board.

(b) Creation of the Lien and Personal Obligation for Assessments. Each Owner of any Lot, by acceptance of a deed therefore, whether or not it shall be so expressed in such a deed, is deemed to covenant and agree to pay to the Association: (i) annual assessments or charges; (ii) special assessments, to be established and collected as hereinafter provided; and (iii) specific special assessments levied by the Board hereunder against any particular Lot, including, but not limited to, reasonable fines imposed hereunder and assessments levied under Paragraph 16 hereunder.

All such assessments, together with charges, interest, costs, and reasonable attorney's fees actually incurred, and if the Board so elects, rents, shall be a charge on the Lot and shall be a continuing lien upon the Lot against which each assessment is made. Such amounts shall also be the personal obligation of the Person who was the Owner of such Lot at the time when the assessment fell due. Each Owner and his or her grantee shall be jointly and severally liable for all assessments and charges due and payable at the time of any conveyance. The Association, in the Board's discretion, may, but shall not be obligated to, record a notice of such a lien in the Monroe County, Georgia records evidencing the lien created under this Declaration.

Assessments shall be paid in such a manner and on such dates may be fixed by the Board. No Owner may exempt himself or herself from liability, or otherwise withhold payment of assessments, for any reason whatsoever, including, but not limited to, non-use of the Commons Property, the Association's failure to provide services or perform its obligations required hereunder, or inconvenience of discomfort arising from the Association's performance of its duties.

Such lien shall be prior and superior to all other liens, except (a) the liens to all taxes, bonds, assessments, and other levies which by law would be superior, and (b) the lien or charge of any first Mortgage of record (meaning any recorded Mortgage with first priority over the other Mortgages) made in good faith and for value.

(c) Delinquent Assessments. All assessments and related charges not paid on or before the due date shall be delinquent, and the Owner shall be in default.

(i) If the annual assessment, or any part thereof, is not paid in full by the tenth (10<sup>th</sup>) day of the month which it is due or if any other charge is not paid within ten (10) days of the due date, a late charge equal to ten percent (10%) of the amount not paid, or such higher amounts as may be authorized by the Board and Georgia law, may be imposed without further notice or warning to the delinquent to the Owner, and interest at the rate of ten percent (10%) per annum or such higher rate as permitted under Georgia law shall accrue from the due date.

(ii) If part payment of assessment and related charges is made, the amount received may be applied by the Board, in respective order, to costs and attorney's fees, late charges, interest, delinquent, and current assessments. Late charges may be assessed on delinquencies which are created by the application of current payments to outstanding delinquent assessments or charges.

(iii) If assessments, fines or other charges, or any part thereof, remain unpaid more than thirty (30) days after the assessment payments first become delinquent, the Association, acting through the Board, may institute suit to collect all amounts due pursuant to the provisions of the Declaration, the Bylaws, and Georgia law, including reasonable attorney's fees actually incurred, and suspend the Owner's and Occupant's right to use the Commons Property (provided, however, the Board may not deny ingress or egress to or from the Lot).

(d) Computation of Operating Budget and Assessment. Prior to the beginning of each fiscal year, the Board shall prepare a budget covering the estimated costs of operating the Property during the coming year, and the Board shall establish the annual assessment or the installments for the coming year. The Board shall cause the budget and notice of the assessment(s) to be delivered to each member at least thirty (30) days prior to the due date for such assessments. The budget and the assessment shall become effective unless disapproved at a duly called Association annual meeting by a vote of a majority of the total Association membership; however, if a quorum is not obtained at the annual meeting, the budget shall become effective even though a vote to disapprove the budget and assessment shall take effect without a meeting of the members.

If the membership disapproves the proposed budget or the Board fails for any reason to determine the budget for the succeeding year, then, until the budget is determined as provided herein, the budget in effect for the current year shall continue for the succeeding year. However, the Board may propose a new or adjusted budget at any time during the year by causing the proposed budget and assessment to be delivered to the members at least thirty (30) days prior to the proposed effective date thereof. Unless a special meeting is requested by the members, as provided in the Bylaws for the special meetings, the new or adjusted budget and assessment shall take effect without a meeting of the members.

(e) Special Assessments. In addition to the annual assessment provided for in subparagraph (b) above and assessments authorized under Paragraphs 5(b) hereof, the Board may at any time levy a special assessment against all Owners, notice of which shall be sent to all Owners. However, prior to becoming effective, any special assessments which would cause the total of special assessments levied against any Lot in one calendar year to exceed two hundred (\$200.00) dollars at first shall be approved by the affirmation vote of at least two-thirds (2/3) of eligible Owners present or represented by proxy at a special or annual meeting of the members, notice of which shall specify that purpose.

(f) Capital Budget and Contribution. The Board may prepare an annual or multi-year capital budget which shall take into account the number and nature of replaceable assets, the expected life of each asset, and the expected repair or replacement cost. The Board shall set the required capital contribution, if any, in an amount sufficient to permit meeting the projected capital needs of the Association, as shown on the capital budget, with respect both to amount and timing by equal annual

assessments over the period of the budget. The capital contribution required, if any, shall be fixed by the Board and included within the budget and assessments as provided in subparagraph (d) above. The Declarant, during the Declarant Control Period, shall name no obligation to budget or provide for capital reserves.

(g) Statement of Account. Any Owner, Mortgagee, or a Person having executed a contract for the purchase of a Lot, or a lender considering a loan to be secured by a Lot, shall be entitled upon written request, to a statement from the associate setting forth the amount of assessments due and unpaid, including any late charges, interest, fines, or other charges against such Lot. The association shall respond in writing within five (5) business days or receipt of the request for a statement; provided, however, the Association may require the payment of a fee, not exceeding ten (\$10.00) dollars or such higher amount as determined by the Board, as a prerequisite to the issuance of such a statement. Such written statement shall be binding on the Association as to the amount of assessments due on the Lot as of the date specified therein. The Association may require an additional fee not to exceed fifty (\$50.00) dollars if the Association provides a copy of the Declaration and Bylaws to any such person in connection with a closing or otherwise upon request.

(h) Surplus Funds and Common Profits. Common profits from whatever source shall be, applies to the payment of Common Expenses. Any surplus funds remaining after the application of such common profits to the payment of Common Expenses shall, at the Board's option, either be distributed equally to the Owners or credited to the next assessment chargeable to the Owners, or added to the Association's reserve account.

(i) Declarant's Obligation for the Payment of Assessments. So long as the Declarant owns any Lots in the Community or seven (7) years from the date of recording of this Declaration, whichever comes first, on an annual basis, the Declarant may elect, but shall not be obligated, to reduce the assessment for any fiscal year by paying a subsidy on such terms and under such circumstances as the Declarant in its sole discretion may decide. The payment of such subsidy shall under no circumstances obligate the Declarant to continue payment of a subsidy in the future. The Declarant's option to subsidize the assessment may be satisfied in the form of cash or by "in kind" contributions of services or materials, or a combination of these.

(j) Date of Commencement of Assessments. Assessments shall commence as to a Lot on the earlier of (a) the first day of the month following the occupancy of the Lot for residential purposes, or (b) the first day of the month a builder, developer or person intending to construct and/or occupy a residence on the Lot purchases a Lot from the Declarant for the purpose of construction of a residence and resale of the Lot and residence. The Declarant or a builder or developer who purchases a Lot for the purposes of construction of a residence and resale of the Lot and residence shall not be responsible for the payment of any type of assessment except as provided herein; provided, however, assessments shall commence on Lots containing occupied residences that are owned by Declarant or any builder or developer on the first day of the month following the occupancy of the residence located on the Lot. Assessments shall be due and payable in a manner and on the schedule that the Board of Directors provides. The first annual common assessment shall be adjusted according to the number of months then remaining in that fiscal year.

#### 9. INSURANCE.

(a) Individual Lot Owner Insurance. Each owner shall carry blanket all-risk casualty insurance, if reasonably available, or if not reasonably available, fire and extended coverage, on his or her Lot and structures constructed. Each Owner further covenants and agrees that, in the event of damage and destruction of structures on his Lot, the Owner shall proceed promptly to repair or to reconstruct the damage structure in a manner consistent with the original construction or such other plans and specifications as are approved by the Association or ACC, unless a determination not to rebuild is made and agreed upon in writing by the Association. The Owner shall pay any costs or repair or reconstruction which is not covered by insurance proceeds. If the structure is totally destroyed and a determination is made not to rebuild or reconstruct, the Owner shall clear the Lot of all debris and return it to substantially the natural state, including, but not limited to siding the lot, in which it existed prior to the beginning of construction within ninety (90) days of the destruction or as

otherwise approved by the Association, and thereafter the Owner shall continue to maintain the Lot in a neat and attractive condition consistent with the community-wide standard.

(b) Association Liability and Directors' and Officers' Liability Insurance. The Board shall obtain a public liability policy applicable to any Common Property covering the Association and its members for all damage or injury caused by the negligence of the Association or any of its members or agents in their capacities as such, and, if reasonably available, directors' and officers' liability insurance. The public liability policy shall have a combined single limit of at least one million (\$1,000,000.00) dollars.

(c) Premiums and Deductibles on Association Policies. Premiums for all insurance obtained by the association shall be a Common Expense of the Association. The policies may contain a reasonable deductible, and the amount thereof shall not be subtracted from the face amount of the policy in determining whether the insurance at least equals the full replacement cost.

(d) Policy Terms. All such insurance coverage obtained by the Board shall be written in the name of the Association, as trustee, for the respective benefited parties, as further identified in subparagraph, (ii) below. Such insurance shall be governed by the provisions hereinafter set forth:

(i) All policies shall be written by a company licensed to do business in Georgia.

(ii) All policies on the Common Property shall be for the benefit of the Association and its members. Any policies covering improvements on Lots shall be for the benefit of Lot Owners and their Mortgagees, as their interest may appear.

(iii) Exclusive authority to adjust losses under policies obtained by the Association shall be vested in the Board; provided, however, no Mortgagee having an interest in such losses may be prohibited from participating in the settlement negotiations, if any, related thereto.

(iv) In no event shall the insurance coverage obtained and maintained by the Board hereunder be brought into contribution with insurance purchased by Individual Owners occupants, or their Mortgagees, and the insurance carried by the Association shall be primary.

(v) All casualty insurance policies shall have an Inflation guard endorsement and an agreed amount endorsement if these are reasonably available and all insurance policies shall be reviewed annually by one or more qualified persons, at least one of whom must be in the real estate industry and familiar with construction in the county where the Property is located.

(vi) The Board shall be required to make every reasonable effort to secure insurance policies that will provide for the following:

(1) a waiver of subrogation by the insurer is as to any claims against the Board, the Association's manager, the Owners and their respective tenants, servants, agents, and guests;

(2) a waiver by the insurer of its rights to repair and reconstruct instead of paying cash;

(3) a provision that no policy may be cancelled, invalidated, suspended or subjected to non renewal on account of anyone or more individual Owners;

(4) a provision that no policy may be cancelled, invalidated, suspended, or subjected to non-renewal on account of any defect or the conduct of any director, officer, or employee of the Association of it duly authorized manager without prior demand in writing delivered to the Association to cure the defect or to cease the conduct and the allowance of reasonable time thereafter within which a cure may be effected by the Association, its, manager, any Owner or Mortgagee;

(5) that any "other insurance" clause in any policy exclude individual Owner's policies from consideration; and

(6) that no policy may be cancelled or substantially modified or subjected to non-renewal without at least thirty (30) days prior written notice to the Association.

(e) Additional Association Insurance. In addition to the other insurance required by this Paragraph, the Board shall obtain workmen's compensation insurance, in and to the extent necessary to satisfy the requirements of applicable laws, and fidelity bond or bonds on directors, officers, employees, and other persons handling or responsible for the Association's funds or dishonesty insurance. The amount of fidelity coverage of dishonest insurance shall be determined in the directors' best business judgment, but if reasonably available, shall not be less than three (3) months assessments plus a reasonable amount to cover all or a reasonable portion of reserve funds in the custody of the Association at any time during the term of the bond; provided, however, fidelity coverage herein required may be reduced based on financial controls which take one or more of the

following forms: (a) the Association or management company, if any, maintains the bank account for the working account and the reserve account, each with appropriate access controls and the bank in which funds are deposited sends copies of the monthly bank statements directly to the Association; (b) the management company, if any, maintains separate records and back accounts for each association that uses its services and the management company does not have the authority to draw checks on, or to transfer funds from, the Association's Reserve account; or (c) two Board members must sign any checks written on the reserve account. Bonds shall contain a waiver of all defenses based upon the exclusion of persons serving without compensation and may not be cancelled, substantially modified, or subjected to non-renewal without at least thirty (30) days prior written notice to the Association. The Association shall also obtain construction code endorsements, and flood insurance, if and to the extent necessary to satisfy the requirements of The Mortgage Corporation of the Federal Mortgage Association.

#### 10. ARCHITECTURAL CONTROLS.

(a) Architectural Standards. Except for the Declarant and as otherwise provided herein, no Owner, Occupant, or any other person may, without first obtaining written approval of the Declarant or ACC,

- (i) make any endorsements onto the Common Property,
- (ii) construct any dwelling or other improvement on a Lot,
- (iii) make any exterior change, alteration or construction on a Lot or any alteration of the Lot which affects the exterior appearance of the Lot, or
- (iv) erect, place or post an object, sign, clothesline, playground equipment, light, storm door or window, artificial vegetation, exterior sculpture, fountains, flags or other things on the exterior of the Lot, on the dwelling on the Lot, in any windows of the dwelling, or on any Common Property.

The standard of approval of such improvements shall include, but not limited to: (1) aesthetic consideration, (2) materials to be used, (3) compliance with the Community-Wide Standard, this Declaration, or the design standards which may be adopted by the Board or the ACC, (4) harmony with the external design of the existing buildings, Lots and structures, and the location in relation to surrounding structures and topography, and (5) any other matter deemed to be relevant or appropriate by the Board or ACC.

Applications for approval of any such architectural modifications shall be in writing and shall provide such information as the ACC may reasonably require. The ACC or its designated representative shall be the sole arbiter of such application and may withhold approval for any reason, including purely aesthetic considerations, and the Association, acting through the Board, shall be entitled to stop any construction which is not in conformance with approved plans. The Board or the ACC may publish written architectural standards for exterior and Common Property alterations or additions.

The ACC or the Board, subject to this sub paragraph (a), may allow such encroachments on the Common Property as it deems acceptable.

If the Board or ACC fails to approve or to disapprove such applications within forty-five (45) days after the application and all information as the Board or ACC may reasonably require have been submitted, then the Owner submitting the application may issue written notice, by certified mail, to the Association president, informing of the Owner's intent to proceed with the modifications as identified in the application, unless the Association issues a written disapproval of the application within ten (10) days of receipt of the Owner's notice. If the Board fails to issue such written disapproval within ten (10) day period, then its approval will not be required and this subsection will be deemed complied with as to the items specifically identified in the application; provided, however, even if the requirements of this subsection are not satisfied, nothing herein shall authorize anyone to construct or maintain any structure or improvements that is otherwise in violation of the Declaration, By Laws or Association rules or of any applicable zoning or other laws.

(b) Architectural Control Committee. The ACC shall constitute a standing committee of the Association. The ACC shall consist of the Board unless the Board delegates to other Persons the

Authority to serve on the ACC. The ACC shall have the authority to select and employ professional consultants to assist it in discharging its duties, the cost of such consultants to be paid by the Owner of any Lot for which plans and specifications have been submitted for approval. The Owner of any such lot shall be responsible for paying the full costs of each review, whether or not submitted plans and specifications are approved by the ACC, and the ACC may require payment of all such costs prior to approval of plans and specifications. The ACC also may charge reasonable fees to cover the cost of review or inspections performed hereunder, and any such fees shall be published in the design standards.

(c) Condition of Approval. As a condition of approval for a requested architectural change, modification, addition or alteration, an Owner, on behalf of himself or herself and his or her successors-in-interest, shall assume all responsibilities for maintenance, repair, replacement and insurance to and on such change, modifications, addition and alteration. In the discretion of the Board or the ACC, an Owner may be made to verify such condition of approval by written instrument in recordable form acknowledged by such Owner on behalf of himself or herself and all successors-in-interest. The Declarant shall not be obligated to obtain ACC approval so long as the Class "B" Control Period Exists.

(d) Limitation of Liability. Review and approval of any application pursuant to this Paragraph may be made on any basis, including solely the basis of aesthetic considerations, and neither the Board nor the ACC shall bear any responsibility for ensuring the designs, quality, structural integrity or soundness of approved construction or modifications, nor for ensuring compliance with building codes, zoning regulations and other governmental requirements. Neither the Declarant, Association, Board, ACC, or member of any of the foregoing shall be held liable for any injury, damages or loss arising out of the manner, design or quality of approved construction or modifications to any Lot, nor may any action be brought against the Association, the Board, the ACC, or any member thereof, for any such injury, damage or loss.

(e) No Waiver of Future Approvals. Each Owner acknowledges that the members of the Board and the ACC will change from time to time and that interpretation, application and enforcement of the architectural standards may vary accordingly. The approval of either the Declarant, Board or ACC, or any proposals, plans and specifications or drawings for any work done or proposed or in connection with any other matter requiring the approval of the Board or the ACC shall not constitute a waiver of any right to withhold approval or consent as to any similar proposals, plans and specifications, drawings, or matters whatever subsequently or additionally submitted for approval or consent.

(f) Enforcement. Any construction, alteration or other work done in violation of this Paragraph, the Declaration, and the Bylaws, the Design standards or any applicable zoning regulations shall be deemed to be non-conforming. Upon written request from the Board, a violating Owner shall, at his or her own cost and expense, remove such non-conforming construction, alteration or other work and restore the property to substantially the same condition as existed prior to such construction, alteration or work. Should owner fail to do so, the Board or its designees shall have the right in addition to all other available remedies, to enter the property, remove the violation and restore the property, or obtain a court order compelling the violating Owner to do so. All costs thereof, including reasonable attorney's fees, may be assessed against such Lot.

In addition to the above, the Board shall have the authority and standing, on behalf of the Association, to impose reasonable fines and to peruse all legal and equitable remedies available to enforce the provisions of this Paragraph and its decisions or those of the ACC. All costs of any such action, including reasonable attorney's fees, may be assessed against such Lot.

If any Owner or Occupant makes any exterior change, alteration, or construction upon the Common Property in violation of this paragraph, he or she does so at his or her sole risk and expense. The Board may require that the change, alteration or construction remains on the Common Property without reimbursement to the Owner or Occupant for any expense he or she may have incurred in making the change, alteration or construction. Furthermore, the Board shall have the authority to record the Monroe County, Georgia land records notices of violation of the provisions of this paragraph.

(g) Commencement of Construction. All improvements approved by the ACC hereunder must be commenced within one year from the date of approval. If not commenced within such a time, then such approval shall be deemed automatically revoked by the ACC, unless the ACC gives a written extension for commencing the work. Additionally, except with written ACC approval otherwise, and except for delays caused by strikes, fires, national emergencies, critical materials shortages or other intervening forces beyond the control of the Owner, all work approved by the ACC hereunder shall be completed within 90 days of commencement.

(h) Applicability to the Declarant. The provisions contained within this Paragraph shall not apply to the Declarant.

#### 11. USE RESTRICTIONS.

Each owner of a Lot shall be responsible to ensuring that the Owner's family, guests, tenants and Occupants Comply with all provisions of this Declaration, the Bylaws, Articles of Incorporation and the rules and regulations of Adamsville Park. Furthermore, each Owner and Occupant shall always endeavor to observe and promote the cooperative purposes for which the Association was established. In addition to any rights the Association may have against the Owner's family, guests, tenants, or Occupants, the Association may take action under this Declaration against the Owner as if the Owner committed the violation in conjunction with the Owner's family guests, tenants or Occupants.

(a) Residential Use. Each Lot shall be used for residential purposes only, and no trade or business of any kind may be conducted in or from a Lot or any part of the Property, including business uses ancillary to primary residential use, except that the Owner or Occupant residing in a dwelling on a Lot may conduct such ancillary business activities within that dwelling so long as (1) the existence or operation of the business activities within that dwelling so long sound, smell from the exterior of the dwelling; (2) the business activity does not involve visitation of the Lot by employees, clients, customers, suppliers or other business invitees; provided, however, this provision shall not preclude delivery of materials of items by United States Postal delivery or by other customary parcel delivery services (U.P.S., FedEx, etc.); (3) the business activity conforms to all zoning requirements for the Property; (4) the business activity does not increase traffic in the Property more than with customary residential occupancy; (5) the business activity does not increase the insurance premium paid by the Association or otherwise negatively affect the ability of the Association to obtain insurance coverage for the Common Property, if any; and (6) the business activity is consistent with the residential character of the property and does not constitute a nuisance or a hazardous or offensive use, or threaten the security or safety of other residence of the Property, as may be determined in the Board's sole discretion.

The terms "business" and "trade", as used in this provision, shall be constructed to have their ordinary, generally accepted meanings, and shall include, without limitation, any occupation, work, or activity undertaken on an ongoing basis which involves the provision of goods or services to persons other than the provider's family and for which the provider receives a fee, compensation, or from of consideration, regardless of whether: (i) such activity is engaged in full or part-time; (ii) such activity is intended to or does generate a profit; or (iii) a license is required therefore. Notwithstanding the above, the use of a Lot by an on-site management company operation on behalf of the Association shall not be considered a trade of business within the meaning of the subparagraph.

(b) Number of Occupants. The maximum number of occupants in a dwelling on a Lot shall be limited to two (2) people per bedroom in the dwelling. "Occupancy," for purposes hereof, shall be defined as staying overnight in a dwelling for a total of more than thirty (30) days, either consecutive or nonconsecutive, in any calendar year. This occupancy restriction shall not apply to require the removal of any person lawfully occupying a dwelling on the Effective Date hereof. Upon written application, the Board shall grant variances to this restriction to comply with provisions of the Fair Housing Amendments Act of 1998 or any amendments thereto.

If an Owner of a Lot is a corporation, partnership, trust or other legal entity not being a natural person, the entities shall designate in writing to the Board the name(s) of the person(s) who will occupy the dwelling on the Lot. The designated person(s) to occupy the dwelling may not be changed more frequently than once every six (6) months.

(c) Subdivision Lots and Outbuildings. No Lot may be subdivided into a smaller Lot and no structure of temporary character, trailer, tent, shack, carport, garage, barn or other outbuilding shall be erected or used by any Owner or Occupant on any portion of the property, at any time, either temporarily or permanently, except by the Declarant, or written Board of Declarant approval.

(d) Prohibition of Damage, Nuisance and Noise. Without prior written Board consent nothing shall be done or kept on the Property or any part thereof which would be in violation of any statute, rule, ordinance, regulation, permit or other validly imposed requirements of any governmental body.

Noxious, destructive, offensive or unsanitary activity shall not be carried upon the Property. No Owner or Occupant may use or allow the use of the Lot or any portion of the Property at any time, in any way, which may endanger the health of the property of other Occupants, unreasonably annoy, disturb or cause embarrassment or discomfort to other Owners or Occupants, or, in the Board's discretion, constitute a nuisance. The intention of this provision is to grant the Association and aggrieved Owners and Occupants a right of redress for actions, activities or conduct which unreasonably annoyances or disturbances shall include, but not be limited to, the following:

(i) Any screaming, shouting, excessively loud talking whistling, or playing of music or television either outside of a Lot at any time or within a Lot if such conduct can be heard in the normal course of activities in a dwelling on any other Lot;

(ii) Any fighting, raucous behavior or insobriety either outside of a Lot at any time within a Lot if such conduct can be heard in the Normal course of activities in a dwelling on any other Lot;

(iii) The use of any alarm, equipment, or devise, mechanical or otherwise, which creates or produces excessively loud sounds or any vibrations either outside of a Lot at anytime or within a Lot if such sounds can be heard or vibrations felt in the normal course of activities in a dwelling on any other Lot;

(iv) Any threatening or intimidating conduct towards any resident, guests or pet at the Property;

(v) Any conduct which, in the Board's reasonable discretion, creates any danger or risk of injury to others or damage to property at the Property or which creates any threat to health or safety of any other resident or pet;

(vi) Any excessively loud play or playground activities either outside of a Lot at any time or within a Lot if such conduct can be heard in the normal course of activities in a dwelling on any other Lot;

(vii) Any conduct which creates any noxious or offensive odor either outside of a Lot at any time or within a Lot if such odors can be detected in the normal course of activities in a dwelling on any other Lot;

(viii) Any similar action or activity outside of a Lot on the Property, or which occurs inside a Lot but which interferes with the peaceful use and enjoyment of other Lots by any other Owner, members of his or her family, guests, invitees, or Occupants of her or her Lot; or

(ix) Any construction or similar activities in a Lot which can be heard in other Lots between the hours of 9 p.m. and 7:30 a.m.

However, nothing herein shall be constructed to affect the rights of an aggrieved Owner or Occupant to proceed individually against a violator hereof for relief from interference with his or her property or personal rights. No claim for any loss, damage or other wise shall exist by an aggrieved Owner or Occupant against the Association for failure to enforce to provisions hereof if the aggrieved Owner or Occupant has not personally pursued all available remedies against the violator for redress provided under Georgia law.

No Lot Owner or Occupant may use or allow the use of the Lot in any manner which creates noises between the hours of 11 p.m. and 7:30 a.m. which can be heard by persons in another Lot that will, in the Board's sole discretion, unreasonably interfere with the rights, comfort or convenience of any other Owner, members of his or her family, guests, invitees, or Occupants of his or her Lot.

No Owner, Occupant or agent of such Owner or Occupant shall do any work which, in the Board's reasonable opinion, would jeopardize the soundness or safety of the Property or any structure thereon, would reduce the value thereof, or would impair any easement or other interest in the Property, without prior written consent of all Owners and their Mortgagees.

(e) Firearms and Fireworks. The display or discharge of firearms on any Lot is prohibited; provided, however, that the display of lawful firearms is permitted by law enforcement officers. The term "firearms" includes "B-B" guns, pellet guns, and other firearms of all types, regardless of size. The term "fireworks" shall include those items as listed in O.C.G.A. Section 25-10-1.

(f) Pets. No Owner or Occupant may keep any pets other than a reasonable number of generally recognized household pets on any portion of the Property, as determined by the Board's discretion.

No Owner or Occupant may keep, breed or maintain any pet for any commercial purpose. Pets may not be left unattended outdoors. Dogs must be kept on a leash and be under the physical control of a responsible person at all times while outdoors in unfenced areas. No structure for the care, housing, or confinement of any pet shall be constructed or maintained on any part of the Property without prior written ACC approval as provided herein. Feces left by pets upon any Lot or in any dwelling, including the pet Owner's Lot or dwelling, must be removed promptly by the owner of the pet or the person responsible for the pet.

Any Owner or Occupant who keeps or maintains any pet on any portion of the Property shall be deemed to have indemnified and agreed to hold the Association, its directors, officers, and agents free and harmless from any loss, claim or liability of any kind of character whatever arising by reason of keeping or maintaining such pet within the Properties.

(g) Parking. No Owner or Occupant may keep or being parked on the Property more than a reasonable number of vehicles per Lot at any time, as determined by the Board; provided, however, the Board may adopt reasonable rules limiting the number of vehicles which may be parked at the Property. Vehicles only may be parked in garages, designated parking spaces or other areas authorized in writing by the Board or Declarant.

Disabled and stored vehicles are prohibited from being parked on the Property, except in garages. For purposes of the subparagraph, a vehicle shall be considered "disabled" if it does not have a current license tag or is obviously inoperable. A vehicle shall be considered "stored" if it remains on the Property, other than in a garage, for fourteen (14) consecutive days or longer without prior written Board permission.

Boats, trailers, buses, trucks with a load capacity of one (1) ton or more and vans (excluding mini-vans and sport utility vehicles used as passenger vehicles), recreational vehicles (RV's and motor homes), vehicles used primarily for commercial purposes and containing visible evidence of commercial use (such as tool boxes, tool racks, business decals or signs, or other visible business evidence), and vehicles with commercial writings on their exteriors are also prohibited from being parked on a Lot or on the Property, except (1) in garages or as otherwise approved by the Board, or (2), in case of service vehicles, on temporary basis during daytime business hours or during emergencies for the purpose of serving a Lot.

(h) Signs. Except as many may be required by legal proceedings, no signs, advertising poster or billboards of any kind shall be erected, placed, or permitted to remain on the property without the prior written consent of the Board or its designee, except that two (2) professional security dwelling on a Lot and one (1) professionally lettered "For Rent" or "For Sale" signs not to exceed two (2) feet by two (2) feet in size may be displayed from within a dwelling on a Lot being offered for sale or for

lease. The Declarant and the Association shall have the right to erect reasonably and appropriate signs. The Declarant and the Association also shall have the authority to adopt regulations permitting temporary signs on Lots announcing open houses, birthdays, births or other events for limited periods of time.

(i) Rubbish, Trash and Garbage. All rubbish, trash and garbage shall be regularly removed from the Lot and shall not be allowed to accumulate therein. Rubbish, trash, and garbage shall be disposed of in appropriated sealed bags and placed in proper receptacles for collection.

(j) Impairment of Dwelling Easements. An Owner shall do no act or any work that will impair the structural soundness or integrity of another dwelling or impair any easement of hereditaments, nor do any act nor allow any condition to exist which will adversely affect the other Lots or their Owners or Occupants.

(k) Unsightly or Unkempt Conditions. The pursuit of hobbies or other activities, including, but not limited, to the assembly and disassembly of motor vehicles and other mechanical devices, which might tend to cause disorderly, unsightly or unkempt conditions, shall not be pursued or undertake on any part of the property. Clothing, bedding, rugs, mops, appliances, indoor furniture, and other household items shall not be placed or stored outside the dwelling. Only appropriate outdoor items, such as neatly stacked firewood, patio furniture, grills, and bicycles may be kept on the patio or deck serving the Lot.

(l) Garages. No Owner or Occupant shall park his or her car or any motor vehicles on any portion of the Property, other than in the garage, unless the maximum number of cars or similarly sized motor vehicles which can be parked in the garage according to its design capacity area already parked in said garage. Garage doors shall remain closed at all times, except for necessary use, ingress, and egress. All garages shall be maintained in such a manner that parking for the maximum number of motor vehicles for which it was originally designed to hold is allowed possible.

(m) Antennas and Satellite Dishes. No Direct broadcast satellite (DBS) antenna or multi-channel multi-point distribution service (MMDS) larger than one meter in diameter shall be placed, allowed, or maintained upon any portion of the property, including a Lot. DBS and MMSA antennas one meter or less in diameter and television broadcast service antennas may only be installed in accordance with Federal Communication Commission (FCC) rules and the rules and regulations. Such items shall be installed in the least conspicuous location available on the Lot which permits reception of an acceptable signal.

(n) Architectural Control. No building shall be erected, placed or altered on any lot until the construction plans and specifications and plans showing the location of the structure have been approved by the ACC, as to the quality of workmanship and materials, to include comparable finishes to said property on all homes unless omitted in writing by the ACC, harmony of external design with existing structures, and as to location with respect to topography and finish grade elevation. All mailboxes are to be approved by the ACC. Any later additions or alterations to dwelling upon said property must be submitted by approval by the ACC, and must be completed expeditiously in accordance with such approved plans and specifications.

(o) No Building shall be located on any lot nearer to the lot line than the minimum setback line shown of the recorded plat. For the purpose of this covenant, eaves, steps and carports, and open porches shall be considered as part of building provided, however, that this shall not be constructed to permit any portion of building, or Lot to encroach upon another Lot without approval from the ACC.

(p) No Lot shall be used except for residential purposes. No building shall be erected, altered, placed or permitted to remain on any Lot other than as detached single-family dwelling not to exceed two and one-half stories in height excluding basement.

(q) No schools, churches, kindergartens, temporary buildings, shacks, tents, mobile homes, modular homes, re-locatable or relocated homes shall be placed or maintained on any Lot in the subdivision.

(r) No Owner may obstruct or re-channel the drainage flows after installation of drainage swales, storm sewers or utility easements. As to any Lot on which a storm drain is located, and easement is reserved to the county authorities for the purpose of repairing or maintaining said storm drain.

(s) Satellite Dishes. Any homeowner desiring to install a satellite dish must have such apparatus installed in the rear/back yard only. The location of such dish must be screened from the view and/or side view of a corner Lot. Location must also meet all set back, rear, and side yard requirements.

(t) No Lot or parcel of land shall be used as a dumping ground for rubbish, trash or garbage, except for developer or builder, during construction stages, even so, all construction debris will be removed no more that 150 days after last home is constructed and sold, nor shall any lot be used for keeping or breeding livestock animals or poultry of any kind, except that household pets may be kept provided they are not kept for breeding or maintained for commercial purposes. All garbage containers shall be decoratively screened, so as not to be visible from the street of adjoining lots, except on pick-up days.

(u) Window units for air conditioners are prohibited.

(v) Fences and Walls. Fences and walls shall not be erected, placed or altered on any lot nearer to any street than the rear edge of the house built on said lot unless the same be retaining wall or masonry construction, which do not in any event rise above the finished grade elevation of the earth embankment so retained, reinforced, or stabilized, except that this restriction shall not apply to fences or walls which has been approved by the ACC. No such fence or wall shall exceed six (6) feet in height above surrounding ground level. On corner lots, no fence shall be constructed nearer a street line than the alternate building line applicable as said house is constructed. All fences shall be of wood or vinyl privacy and arched between posts.

(w) All lots at street intersections shall be so landscaped as to permit safe sight across the street corner; no fences, signs, nor high shrubbery or trees to be located at the corner of said lot that would create a high traffic or sight problem.

(x) Only ornamental plants and shrubbery shall be allowed between the house and any street line. Any vegetable gardens must be on side or rear yards away from the street.

## 12. LEASING.

(a) Definition. "Leasing," for purposes of the Declaration is defined as the regular, exclusive occupancy of a Lot by any person or persons other than the Owner; provided, however, leasing shall not include exclusive occupancy by the spouse, child or parent of an Owner and shall not include the occupancy by a roommate of an Owner who occupies the Lot as such Owner's primary residence.

If an Owner is a corporation, limited liability company, partnership, trust, or other legal entity not being a natural person or persons, then any natural person who is an officer, director, or other designated agent of such corporation, manager or member of such limited liability company, partner of such partnership, beneficiary or other designated agent of such trust, or agent of such other legal entity shall be deemed an Owner of such Unit for purposes of this Paragraph 12. Such Person's designation as an Owner of such Unit pursuant to this Paragraph 12 shall terminate automatically upon the termination of such person's relationship with the entity holding record title of the Unit.

(b) Leasing Provisions. Leasing shall be governed by the following provisions:

(1) Notice. At least seven (7) days prior to entering into the lease of a Lot, the Owner shall provide the Board of Directors with a copy of the proposed lease, the name, address, and homes and business telephone numbers of the proposed lessee and the names of all other people occupying the Lot, the Owner's address other than the Lot, and such other information as the Board may reasonably require.

(2) General. Lots may be leased only in their entirety; no fraction or portion may be rented. There shall be no subleasing of Lots or assignment of leases unless approved in writing by the Board. No transient tenant may be accommodated in a Lot. All leases shall be in writing and in a form approved by the Board prior to the effective date of this lease. All leases shall be for a period of at least six (6) months except with written Board approval. The Lot Owner must provide the tenant copies of the Declaration, Bylaws, and Association rules and regulations, and the lease form shall provide that the Owner has done so.

(3) Liability for Assessments and Compliance with Declaration, Bylaws, and Rules and Regulations. Any Lease of a Lot in the Community shall be deemed to contain the following provisions, whether or not expressly therein stated, and each Owner covenants and agrees that any lease of a Lot shall contain the following language and agrees that if such language is not expressly contained therein, then such language shall be incorporated into a lease by existence of this covenant on the Lot. Any lessee, by occupancy of a Lot, agrees to the applicability of this covenant and incorporation of the following language into the lease:

(i) Liability for Assessments. Lessee agrees to be personally obligated for the payment of all assessments and all other charges against the Owner which become due during the term of the lease and any other period of occupancy by the lessee or which become due as a consequence of the lessee's activities, including but not limited to, activities which violate provisions of the Declaration, the Bylaws, or the rules and regulations adopted pursuant thereto. The above provision shall not be construed to release the Lot Owner from any obligation, including the obligation for assessments, for which he or she would otherwise be responsible.

When a Lot Owner who is leasing his or her Lot fails to pay any assessment or any other charge for a period of more than thirty (30) days after it is due and payable, then the delinquent Lot Owner hereby consents to the assignment of any rent received from the lessee during the period of delinquency, and, upon request by the Board of Directors, lessee shall pay to the Association all unpaid annual and special assessments and other charges, as lawfully determined and made payable during the term of the lease and any other period of occupancy by lessee; provided, however, lessee need not make such payments to the Association in excess of, prior to the due dates for monthly rental payments unpaid at the time of the Board's request. All such payments made by lessee shall reduce, by the same amount, lessee's obligation to make monthly rental payments to lessor. If lessee fails to comply with the Board's request to pay assessments or other charges, lessee shall pay to the Association all late charges, fines, interest, and costs of collection, including, but not limited to, reasonable attorney's fees actually incurred, to the same extent lessee would be required to make such payments to the Association if lessee were the owner of the premises during the term of the agreement and any other period of occupancy by lessee.

(iii) Compliance with Declaration, Bylaws, and Rules and Regulations. Lessee shall abide by and comply with all provisions of the Declaration, Bylaws and rules and regulations adopted pursuant thereto and shall control the conduct of all other occupants and guests in order to insure compliance with the foregoing. Lessee acknowledges that the violations by lessee or any occupant living with the lessee of any provision of the Declaration, Bylaws, or rules and regulations adopted there under shall constitute a default under this lease. Owner shall cause all occupants of his or her Lot to comply with the Declaration, Bylaws, and rules and regulations adopted pursuant thereto, and is responsible for all violations and losses caused by such occupants, notwithstanding the fact that such occupants of the Lot are fully liable and may be sanctioned for any violation of the Declaration, Bylaws, and rules and regulations adopted pursuant thereto. If the lessee, or a person living with the lessee, violates the Declaration, Bylaws, and rules and regulation for which a fine is imposed, such a fine may be assessed against the lessee and/or the Owner; provided, however, if a fine is not paid by the lessee within the time period set by the Board of Directors, the Owner shall pay the fine upon notice from the Board of the lessee's failure to do so. Unpaid fines shall constitute a lien against the Lot. Any lessee charged with a violation of the Declaration, Bylaws, and rules and regulations adopted pursuant thereto is entitled to the same procedure to which an Owner is entitled prior to the imposition of a fine or other sanction.

Any violation of the Declaration, Bylaws, or rules and regulations adopted pursuant thereto by lessee, any occupant, or any person living with lessee is deemed to be a violation

of the terms of the lease and authorizes the Owner to terminate the lease without liability and evict the lessee in accordance with Georgia law. The Owner hereby delegates and assigns to Adamsville Homeowner's Association, acting through the Board, the power and authority of enforcement against the lessee for breaches resulting from the violation of the Declaration, Bylaws, and the rules and regulations adopted thereto, including the power and authority to evict the lessee on behalf and for the benefit of the Owner, in accordance with the terms hereof, or to require the Owner to do so. In the event the Association proceeds to evict the tenant, any costs including attorney's fees and court costs, associated with the eviction shall be specially assessed against the Lot and the Owner thereof, such being deemed hereby as an expense which benefits the lease Lot and the Owner thereof.

(iii) Use of Common Property. The Owner transfers and assigns to the lessee, for the term of the lease, any and all rights and privileges that the Owner has to use the Commons Property, including, but not limited to, the use of any and all recreational facilities and other amenities.

### 13. SALE OF LOTS

A Lot Owner intending to make a transfer or sale of a Lot or any interest in a Lot shall give the Board written notice of such intention within seven (7) days after execution of the transfer or sales documents. The Owner shall furnish the Board, as part of the notice, the name and address of the intended grantee and such other information as the Board may reasonably require. The Lot Owner transferring or selling his or her Lot must provide the purchaser or new Owner copies of the current Declaration, By Laws, and rules and regulations. This paragraph shall not be constructed to create a right of first refusal in the Association or in any third party.

Within seven (7) days after receiving title to a Lot, the purchaser of the Lot shall give the Board notice of his or her ownership of the Lot. Upon failure of an Owner to give the required notice within the seven-day time period herein, the Board may levy fines against the Lot and Owner thereof, and assess the Owner for all costs incurred by the Association in determining his or her identity.

### 14. MAINTENANCE RESPONSIBILITY.

(a) Associations Responsibility. The Association shall maintain and keep in good repair any Common Property. This maintenance shall include, without limitation, maintenance, repair, and replacement, subject to any insurance then in effect, of all landscaping, grass areas, paving and other improvements, which are situated on the Common Property.

(b) Owner's Responsibility. All maintenance, repair, replacement and improvement of the Lot shall be the responsibility of the Owner and shall be made in a manner consistent with the Community-Wide Standards and this Declaration. In addition, each Owner shall maintain any public right of way located between the Owner's Lot and the curb of the Street(s) bordering such Lot. Such maintenance shall be performed consistent with this Declaration and the Community-Wide Standard established pursuant hereto. Each Owner shall perform his or her responsibility hereunder in such a manner so not to unreasonably disturb other Lot Owners. Such maintenance shall include, but not limited to, maintaining fence in good repair, exterior painting as needed and maintenance of all vegetation and landscaping in good and presentable condition.

The Association shall not be liable for injury or damage to person or property caused by the elements or by the Owner of any Lot, or any other person, or resulting from any utility, rain, snow or ice which may leak or flow from any portion of the Common Property (unless directly and solely caused by the negligence or gross negligence of the Association) or from any pipe, drain, conduit, appliance or equipment which the association shall not be liable to any Owner, guest, or family, for loss or damage, by theft or otherwise, of any property which may be stored in or upon any of the Common Property. The Association shall not be liable to any Owner, or any Owner's Occupant, guest or family for any damage or injury caused in whole or in part by the Association's failure to discharge its responsibilities under this Paragraph where such damage or injury is not foreseeable, natural result of the Association's failure to discharge its responsibilities. No diminution or abatement of assessments shall be claimed or allowed by reason of any alleged failure of the Association to take some action or perform some function required to be taken or performed by the Association under this

Declaration, or for inconvenience or discomfort arising from the making for repairs or improvements which are the responsibility of the Association, or from any action taken by the Association to comply with any law, ordinance, or with any order or directive of any municipal or other governmental authority.

The Association shall repair incidental damage to any Lot resulting from performance of work which is the responsibility of the Association. In performing its responsibilities hereunder, the Association shall have the authority to delegate to such persons, firms or corporations of its choice, such duties as are approved by the Board.

(c) Failure to Maintain. If the Board determines that any Owner has failed or refused to discharge properly his or her obligation with regard to the maintenance, repair or replacement of items of which he or she is responsible hereunder, then the Association's right to provide necessary maintenance, repair, or replacement at the Owner's cost and expense. The notice shall set forth with reasonable particularity the maintenance, repair or replacement deemed necessary by the Board.

Unless the Board determines that an emergency exists or unless the notice required hereunder has already been provided to the Owner for the same violation, the Owner shall have ten (10) days within which to complete maintenance or repair, or if the maintenance or repair is not capable of completion within such a time period, to commence replacement or repair within ten (10) days if the Board determines that an emergency exists or that an Owner has not complied with the demand given by the Association as herein provided, then the Association may provide any such maintenance responsibilities hereunder, the Association discovers that maintenance, repair or replacement is required with respect to an item which is the Owner's responsibility, and such maintenance, repair or replacement must be performed for the Association to properly complete its maintenance project, then the Association may perform such work on behalf of the Owner and at the Owner's expense, without prior notice to the owner, such being deemed an emergency situation hereunder.

If the Board determines that the need for maintenance or repair is in the Area of Common Responsibility and it can cause through the willful or neglect act of any Owner or Occupant to their family, guests, lessees or invitees, then the Association may assess the cost of any such maintenance, repair, or replacement against the Owner's or Occupant's Lot, which shall become a lien against the Lot and shall be collected herein for the collection of assessments.

(d) Maintenance Standards and Interpretations. The maintenance standards and the enforcement thereof and the interpretation of maintenance obligations under the Declaration may vary from one term of the Board to another term of the Board. These variances shall not constitute a waiver by the Board of the right to adopt and enforce maintenance standards under this paragraph. No decision or interpretation by the Board shall constitute a binding precedent with respect to subsequent decisions or interpretations of the Board.

#### 15. MORTGAGEE'S RIGHTS

(a) Unless at least two-thirds (2/3) of the first Mortgagees or Lot Owners give their consent, the Association shall not:

- (i) by act or omission seek to abandon or terminate the Property of the Association;
- (ii) change the pro rate interest or obligations of any kind individual Lot for the purpose of levying assessments or charges or allocating distributions of hazard insurance proceeds or condemnation awards;
- (iii) partition or subdivide any Lot;
- (iv) by act or omission seek to abandon, partition, subdivide, encumber, sell, or transfer the Common Property (the granting of utility easements or rights-of-way for public purposes and the granting of other easements for the benefit of the association shall not be deemed a transfer within the meaning of this clause); or

(v) use hazard proceeds for losses to any portion of the Property (whether to Lots or to Common Property) for other than the repair, replacement, or reconstruction of such portion of the Property.

The provisions of the subparagraph shall not be construed to reduce the percentage vote that must be obtained from Mortgagees or Lot Owners where a larger percentage vote is otherwise required by the Associations Legal Instruments for any of the actions contained in this paragraph.

Where the Mortgagee holding a first Mortgage record or other purchaser of a Lot obtains title pursuant to judicial or non judicial foreclosure of the Mortgage, it shall not be liable for the share of the Common Expense or assessment by the Association chargeable to such Lot which became due prior to such acquisition of title. Such unpaid share of Common Expenses or assessments shall be deemed to be Common Expenses collectable from Owners of all the Lots, including such acquirer, its successors and assigns. Additionally, such acquirer shall be responsible for all charges accruing subsequent to the passage of title, including, but not limited to, all charges for the months in which title is passes.

Upon written request to the association, identifying the name and address of the holder and the Lot number or address, any Eligible Mortgage held by such Eligible Mortgage Holder.

(1) any delinquency in the payment of assessments or charges owed by an Owner of a Lot subject to a first Mortgage held by such Eligible Mortgage Holder which remains unsatisfied for a period of sixty (60) days, and any default in the performance by an individual Lot Owner of any other obligation in under the Association Legal Instruments which is not cured within sixty (60) days;

(2) any lapse, cancellation, or material modification of any insurance policy or fidelity bond maintained by the Association; or

(3) any proposed action which would require the consent of a specified percentage of Eligible Mortgage Holders, as specified herein.

(4) any holder of a first Mortgage shall be entitled, upon written request, to receive within a reasonable time after request, a copy of the financial statement of the Association for the immediately preceding fiscal year, free of charge to the Mortgagee so requesting.

Notwithstanding anything to the contrary herein contained, the provisions of Paragraphs 12 and 13 governing sales and leases shall not apply to impair to the right of any first Mortgagee to: (i) foreclose or take in to a Lot pursuant to remedies contained in its Mortgage; (ii) take a deed or assignment in lieu of foreclosure; or (iii) sell, lease, or otherwise dispose of a Lot acquired by the Mortgagee.

#### 16. GENERAL PROVISIONS

(a) Enforcement. Each owner and every occupant of a Lot shall comply strictly with the Declaration, the Bylaws, the rules and regulations, as they may be lawfully amended or modified from time to time and with any deed restrictions. The Board of Directors may impose fines or other sanctions, which shall be collected as provisions for the collection of assessments. Fines shall be imposed pursuant to the procedure outlined in the Bylaws. Failure to comply with this Declaration, the Bylaws or the rules and regulations shall be grounds for an action for damages or injunctive relief, or both, maintainable by the Declaring, the Board of Directors (on behalf of the Association), or an aggrieved Owner (in a proper case). Failure by the Declarant, Association or any Owner to enforce any of the foregoing provisions shall be a waiver of the right to enforce those provisions in the future.

The Association shall have the authority to record in the Monroe County land Records a notice of violation identifying an uncured violation of the Declaration or rules and regulations regarding the Lot.

The failure of the Association to enforce any provision of the Declaration of any rules or regulation shall not be deemed a waiver of the right of the Association to do so thereafter.

(b) Security. The Association may, but shall not be required to provide measures or take actions which directly or indirectly improve safety in the Community. However, each Owner, for

themselves and their tenants, guest, licensees, and invitees acknowledge and agree that the Association and the Declarant and their respective successors and assigns are not providers, insurers or guarantors or security within the community, nor shall any of the foregoing be held liable for any loss or damage by reason of failure to provide adequate security or of ineffectiveness of security measures taken. It shall be the responsibility of each Owner to protect his or her person and property, and all responsibility to provide security shall lie solely with each Owner.

(c) No Discrimination. No action shall be taken by the Association which would unlawfully discriminate against any person on the basis of race, creed, color, national origin, religion, sex, familial status or handicap.

(d) Implied Rights. The association may exercise the right or any privilege given to it expressly by this Declaration and any use restriction or rule, and every other right or privilege reasonably to be implied from the existence of any right or privilege given to it therein or reasonably necessary to effectuate any such right or privilege.

(e) Electronic Records, Notices and Signatures. Notwithstanding any other portion of this Declaration, records, signatures and notices shall not be denied validity or effectiveness hereunder solely on the grounds that they are transmitted, stored, made or presented electronically.

#### 17. EASEMENTS

(a) Easements for Utilities. There is hereby reserved to the Association blanket easements upon across, above and under all property within the Property for access, ingress, and egress, installation, repairing, replacing, and maintaining all utilities serving the Property or any portion thereof, including, but not limited to, gas, water, sanitary sewer, telephone and electricity, as well as storm drainage and any other service such as, but not limited to, a master television antenna, cable television system, or security system which the Association may have installed to serve the property. It shall be expressly permissible for the Association or its designee as the case may be to install, repair, replace and maintain or to authorize the installation, repairing replacing, and maintaining of such wires, conduits, furnishing any such utility or service request a specific license or easement by separate recordable document, the board shall have the right to grant such easement.

(b) Easement for Entry Features. There is hereby reserved to the Association and easement in ingress, egress, installation, construction, landscaping, and maintenance of entry features and similar streetscapes for the Property in which entry features and similar streetscapes are located. The easement and right herein reserved shall include the right to cut, remove and plant trees, shrubbery, flowers, and other vegetation around such entry features and similar streetscapes and the right to grade the land under and around such entry features.

(c) Construction and Sale of Period Easement. Notwithstanding any provisions contained in the Declaration, use restriction, rules and regulations, design guidelines, and any amendments thereto, so long as Declarant or a Builder owns any Property in Adamsville Park for development and/or sale, Declarant reserves and easement across all Property for Declarant to maintain and carry on, upon such portion of the Property as Declarant may be required, convenient or incidental to Declarant's development, construction, and sales activities related to property described on Exhibit "B" to this Declaration, including but without limitation, (a) right of access, ingress, and egress for vehicular and pedestrian traffic and construction activities over, under, or in the Property, including, without limitation, any Lot (b) the right to tie into any portion of the property with driveways, parking areas and walkways, (c) the right to tie into and/or otherwise connect and use (without a tap-on or other fees for doing so), replace, relocate, maintain and repair any device which provides utility or similar services including, without limitation, electrical, telephone, natural gas, water, sewer and drainage lines and facilities constructed or installed in, on, under and/or over the Property, (d) the right to grant easements over, under, in or on the Property, including, without limitation, the Lots, for the benefit of neighboring properties for the purpose of tying into an/or otherwise connections and using sewer and drainage lines and facilities constructed or installed in, on, under and/or over the Property, (e) the right to carry on sales and promotional activities in the Property, (f) the right to erect and maintain signs, and (g) the right to construct and operate business offices, construction trailers, model residences, and sales offices. Declarant may use residences, offices, or other buildings owner or

leased by Declarant as model residences and sales offices. Rights exercised pursuant to such reserved easement shall be exercised with minimum interference to the quiet enjoyment of affected property, reasonable steps shall be taken to protect such property, and damage shall be repaired by the persons causing the damage at its sole expense. This paragraph shall not be amended without the Declarant's express written consent until the Declarant's rights hereunder have terminated as hereinabove provided.

#### 18. ANNEXATION AND WITHDRAWAL OF PROPERTY.

(a) Annexation without approval of owners. The Declarant shall have the unilateral right, privilege and option, but not the obligation, from time to time, at any time until all property described on Exhibit "B", attached hereto, has been subject to this Declaration, or for seven (7) years from the Effective Date herein, to subject to the provisions of this Declaration all or any portion of the real property described in Exhibit "B". The Declarant shall have the unilateral right to transfer to any other person the right, privilege, and option to annex additional property which is herein reserved to Declarant, provided that such transferee or assignee shall be the developer of at least a portion of the real property described in Exhibits "A" or "B" and that such transfer is memorialized in a written, recorded instrument executed by the Declarant.

Such annexation shall be accomplished by filing a Supplemental Declaration annexing such property in the public records of Monroe County, Georgia. Such Supplemental Declaration shall not require the consent of Owners, but shall require the consent of the property being submitted hereto, if other than Declarant. Any such annexation shall be effective upon the filing for record of such Supplemental Declaration unless otherwise provided therein.

(b) Annexation with approval of owner. Subject to the consent of the owner and the consent of the Declarant (so long as the Declarant has an option to subject additional property to this Declaration as provided above), upon the affirmative vote, or written consent, or any combination thereof, the Owners holding a Majority of the total Association vote and with the approval of the owner thereof, the Association may annex real property to the provisions of this Declaration and the jurisdiction of the Association by filing for record in the Monroe County, Georgia, records a Supplementary Declaration describing the property being annexed. Any such Supplementary Declaration shall be signed by the President and Secretary of the Association, and any such annexation shall be effective upon the filing for record of such Supplementary Declaration, unless otherwise provided in the Supplementary Declaration.

Annexation shall be accomplished by filing a Supplemental Declaration describing the property being annexed in the public records of Monroe County, Georgia any such Supplemental Declaration shall be signed by the votes constituting a majority of the Lots and by the Owner of the property being annexed. Any such annexation shall be effective upon the filing unless otherwise provided therein.

(c) Withdrawal of Property. The Declarant reserves the right to amend this Declaration unilaterally at any time so long as it holds an unexpired option to expand the community pursuant to this Paragraph 18, without prior notice and with the consent of any person, for the purpose of removing certain portions of the Property then owned by the Declarant or its affiliates from the provisions of this Declaration, to the extent originally included in error or as a result of any changes whatsoever in the plans for the property desired to be effective by the Declarant, provided such withdrawal is not unequivocally contrary to the overall, uniform scheme of development for the Property.

(d) Additional Covenants and Easements. The Declarant may unilaterally subject any portion of the property submitted to this Declaration initially or by Supplemental Declaration to additional covenants and easements. Such additional covenants and easements shall be set forth in a Supplemental Declaration filed either concurrent with or after the annexation of the subject property and shall require the written consent of the Owner(s) of such property, if other than the Declarant.

(e) Amendment. This Paragraph 18 shall not be amended without the prior written consent of the Declarant so long as the Declarant owns or has the right to unilaterally annex any property described in Exhibits "A" or "B" hereto.

**19. AMENDMENTS.**

(a) By Declarant. The Declarant may unilaterally amend this Declaration if such amendment is (i) necessary to bring any provision into compliance with any applicable governmental statutes, rule, regulation, or judicial determination; (ii) necessary to enable any reputable title insurance company to issue a title insurance coverage on the Lots; (iii) required by an institutional or governmental lender or purchaser of mortgage loans, including, for example, the Federal National Mortgage Association or Federal Home Loan Mortgage Corporation, to enable such lender or purchaser to make or purchase mortgage loans on the Lots; (iv) necessary to enable any governmental agency or reputable private insurance company to insure mortgage loans on the Lots; or (v) otherwise necessary to satisfy the requirements of any governmental agency. However, any such amendment shall not adversely affect the title to any Lot unless Owner shall consent thereto in writing. So long as the Declarant still owns property described in Exhibits "A" and "B" for development as part of the properties, it may unilaterally amend this Declaration for any other purpose, provided the amendment shall not materially adversely affect the substantive rights of any Lot Owner. The Board of Directors, with the written consent of Declarant, and without a vote of members, may amend this Declaration for the sole purpose of electing to be governed by and thereafter complying with the provisions of the Georgia Property Owner's Association Act, O.C.G.A. Section 44-3-220, ET. seq.

(b) By Lot Owners. Thereafter except where higher vote is required for action under any other provisions of this Declaration, in which case such higher vote shall be necessary to amend such provision, this Declaration may be amended by the affirmative vote, written consent, or any combination of affirmative vote and written consent of the Owners Holding sixty-seven (67%) percent of the total votes and, while it owns any property described in Exhibit "A" and "B" hereto. Each Lot shall be deemed to have one vote, regardless of the number of Owners per Lot. Notice of a meeting, if any; at which a proposed amendment will be considered, shall state the fact of consideration and the subject matter of the proposed amendment. No amendment shall be effective until filed in the Monroe County, Georgia land records.

In addition to the above material amendments to the Declaration must be approved by Eligible Mortgage Holders who represent at least fifty-one (51%) percent of the votes of Lots that are subject to Mortgages held by Eligible Mortgage Holder shall be deemed implied and consented to if the Eligible Mortgage Holder fails to submit a response to any written proposal for an amendment within thirty (30) days after the Eligible Mortgage Holders receives notice of the proposed amendment sent by certified or registered mail return receipt requested.

If legal action is non instituted to challenge the validity of this Declaration or any amendment hereto within one (1) year of the recording thereof in Monroe County, Georgia land records, then such amendment or document shall be presumed to be validly adopted.

**20. SEVERABILITY**

Invalidation of anyone of these covenants or restrictions by judgment or court order or otherwise shall in no way affect the application of such provision to other circumstances or affect any other provision(s), which shall remain in full force effect.

**21. DURATION**

The covenants, restrictions and easements of the Declaration shall run with and bind the Property and shall insure to the benefit of and shall be enforceable by the Declarant to any Owner, their respective legal representatives, heirs, successors, and assigns, perpetually to the extent permitted by law. However, so long as Georgia law limit's the period during which covenants restrictions lands to certain uses may run, any provision of this Declaration affected by the law shall run with and bind the land so long as permitted by law shall be run automatically extended for successive periods of twenty (20) years, unless fifty-one (51%) of the persons owning Lots execute a document to terminate the covenants containing a legal description of the covenant to be terminated or which other requirement as provided in O.C.G.A 44-5-60. A written instrument reflecting any termination of must be recorded no sooner than, but within two (2) years immediately preceding the beginning of a twenty (20) year renewal period. Every purchaser or grantee of any interest (including

without limitation, a subject interest) in any real property subject to this Declaration, by acceptance of a deed or other conveyance, agrees that provisions of this Declaration may be extended and renewed as provided in this Paragraph.

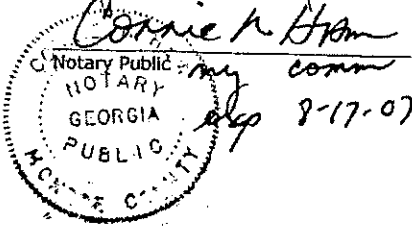

WHEREAS, Den-Ric was designated as "Declarant" in both Declarations, and

WHEREAS, the Declarations provided that a successor Declarant can be designated in a  
"written assignment of Declarant rights in an instrument recorded in the county land records";

WHEREAS, by Assignment of Declarant Rights recorded at Deed Book 1609, page 292, aforesaid records, the rights of The Den-Ric Corporation as Declarant were transferred and assigned to First National Bank of Griffin; and

WHEREAS, a scrivener's error has been found in Section 19 (b) of the Declarations where words were inadvertently omitted from the recorded documents; and

WHEREAS, Section 19(a) of the Declarations authorizes Declarant to unilaterally amend the Declarations so long as it owns property subject to the Declarations and so long as the amendment does not materially affect the substantive right of any Lot Owner; and

WHEREAS, correction of the scrivener's errors simply clarify the obvious meaning of section 19(b) and do not materially affect any substantive right of any Lot Owner;

The Declarations herein referenced are hereby amended as follows:

1. The first sentence of Section 19(b) of both Declarations is hereby amended to read as follows:  
"Thereafter except where higher vote is required for action under any other provisions of this Declaration, in which case such higher vote shall be necessary to amend such provision, this Declaration may be amended by the affirmative vote, written consent, or any combination of affirmative vote and written consent of the Owners Holding sixty-seven (67%) percent of the total votes and by Declarant while it owns any property described in Exhibit "A" and "B" hereto."
2. Except as expressly amended hereby, the Declarations remain in full force and effect.
